




# SWIFT RESPONSE: Reinforcing international partnerships

### INFORMATIONAL



## HISTORY FACT

On July 1, 1965, Air Force legendary fighter ace Col. Robin Olds (without his trademark mustache), delivered the first F-101C to the 189th Tactical Reconnaissance Group. With the delivery, the 189th TRG became the first Air National Guard unit equipped with the Voodoo. After 20 F-101s arrived at the base, crews converted the F-101s to RF-101s by stripping the aircraft of its armor and armament and installing cameras onto the fuselage and nose of each aircraft. Air National Guard aircrews flew the RF-101 on low-altitude reconnaissance missions over North Korea and Vietnam during the late 1960s providing tactical reconnaissance and strike assessment data. During the 11 years the 189th TRG flew the RF-101, two pilots were killed in the aircraft nicknamed the “widow-maker.”



# C-130J carries on Herculean legacy

Six decades have passed since the C-130 aircraft was introduced to the United States Air Force in 1950.

The aircraft, now known as the workhorse of the U.S. Air Force, has remained the longest continuously produced military aircraft, marking it the fifth aircraft to achieve 50 years of consecutive service.

Its remarkable life span is due to its versatile design enabling it to be configured for critical U.S. military operations including combat delivery, aerial refueling, special operations, disaster relief and humanitarian missions.

Since its introduction to Little Rock Air Force base in 1970, the C-130 has been a staple within the local community.

Not only does Little Rock AFB generate and support unrivaled combat airlift across the globe, it is currently the largest C-130 base in the world and home to the C-130 Center of Excellence, an international C-130 training school.

Today, the base houses two models of the aircraft: the C-130H and the C-130J.

The C-130H is praised for its ability to accommodate a variety of oversized cargo, including everything from utility helicopters and six-wheeled armored vehicles to standard palletized cargo and military personnel. In an aerial delivery role, it can airdrop loads up to 42,000 pounds or use its high-flotation landing gear to land and deliver cargo on rough, dirt strips.

"I was fortunate enough to fly the H model in Operation Iraqi Freedom and Operation Enduring Freedom," said U.S. Air Force Maj. Justin Hinrichs, 41st Airlift Squadron assistant operations officer. "The result of those deployments was the effective transport of over 5,000 personnel and 230 tons of cargo, the equivalent of 150 vehicles that didn't have to drive the dangerous roads of Iraq and Afghanistan."

The second, and newest aircraft, to grace the flight line on base is the C-130J Super Hercules aircraft.

From the outside, the difference between the two is minimal, but a defining feature is

the propellers. On the H model, there are four blades on each propeller, and the J model has six blades.

Inside the aircraft there is a stark difference. The C-130H requires a minimum crew of five, with two pilots, a navigator, flight engineer and loadmaster. The modern C-130J only needs three crew members, two pilots and a loadmaster.

"The reduced crew brings with it fewer members assigned to a squadron," said U.S. Air Force Lt. Col. Eric Westby, 61st Airlift Squadron commander. "Yet all the jobs, additional duties, and behind the scenes responsibilities that keep an airlift squadron running are still run by Airmen that are meeting the expectations and handling their business with great energy and success."

The upgraded C-130J incorporates state-of-the-art technology that reduces manpower requirements, lowering operating and support costs. The aircraft's improved engines enables the J model to climb faster and higher, fly farther at a higher cruise speed, and take off and land in a shorter distance. Not to mention the 15 extra feet in the fuselage, increasing 2 pallet spaces in the cargo compartment.

Since its arrival here in 2004, the C-130J has slowly supplanted the legacy H models. New additions to the fleet have continuously filtered in with the latest and last arriving by the end of June for the 19th Airlift Wing. Little Rock AFB will still receive J models for the 314th Airlift Wing in the future. The remainder of the H models on the flight line will be operated by the 189th Airlift Wing Air National Guard.

"We're really just scratching the surface of what the J model can do operationally," Westby said. "We will dig deeper and push the employment envelope even further; I think the 19th Airlift Wing will be on the leading edge of C-130J tactics, techniques, and procedures that will be executed by generations of Airmen to come. It's an exciting time to be a Black Knight."

The C-130J will provide a new era of combat capabilities for Little Rock AFB and carry on the legacy of the workhorse of the Air Force.

# Black Knights deliver Combat Airlift at Swift Response '16

Two 19th Airlift Wing C-130Js and crews from the 41st and 61st Airlift Squadrons participated in Exercise Swift Response '16, one of the premier military crisis response training events in the world for multinational airborne forces.

The exercise included more than 5,000 Soldiers and Airmen from Belgium, France, Germany, Great Britain, Italy, the Netherlands, Poland, Portugal, Spain and the United States, and took place in Poland and Germany.

"The 19th Airlift Wing is postured to rapidly respond with decisive tactical airlift capability anywhere, anytime," said Lt. Col. Sarah Santoro, 41st Airlift Squadron commander. "It's imperative to prioritize participation in multi-national, joint exercises such as Swift Response to keep our joint warfighting skills fresh and ensure our Airmen are trained, prepared, and ready to answer the nation's call to respond to any crisis around the globe."

Black Knight aircrews returned June 15 and were involved in complex planning and mission execution

with multiple international partners, multiple aircraft types, and multi-layered missions.


"Swift Response exercise gave our crews the opportunity not only to push themselves in a challenging, complex operation in an unfamiliar region, but they were put in positions of critical importance to the success of the overall exercise." Lt. Col. Eric Westby, 61st Airlift Squadron commander said. "I think it was a great learning opportunity for our crews, but also a great chance for them to test their skills."

The exercise reinforces the partnerships and interoperability vital for effective combat airlift.

"Partnerships like these are very important," said Westby. "We need and rely heavily upon our international partners to accomplish everything from humanitarian relief and rescue missions to kinetic operations against ISIS and the Taliban. International partnerships are not a luxury, they're an absolute necessity."

The relationships cultivated today will pay dividends down the road in current and future operations.

"Exercises such as Swift Response provide a critical opportunity to build and fortify working relationships

between the services and our international partners, plus we're able to enhance our joint crisis response interoperability as an integrated multi-national team. Notably, Airmen often develop professional working relationships with our partners that will be leveraged in future exercises or operations," Santoro said.



Team Little Rock aircrews partnered with other teams from Dyess AFB, Texas, the West Virginia Air National Guard, Ramstein Air Base, Germany, the British Royal Air Force and Polish air force. They also worked closely with Soldiers from the 82nd Airborne Division at Fort Bragg, N.C. as well as other coalition soldiers. While staging out Bydgoszcz Airport, Poland, the aircrews are working with a Contingency Response Team of Airmen from Travis AFB, California, and Dover AFB, Delaware.

This year, Swift Response demonstrated the allies' ability to respond to a crisis scenario from staging bases in both Europe and the U.S. within 18 hours of notification. A battalion of the 1/82 Airborne made a 10-hour transatlantic flight from Fort Bragg, North Carolina – including en-route refueling, mission planning and parachute rigging – to the exercise area near Torun, Poland. Above Torun, they joined approximately 1,000 paratroopers from the British, 16 Air Assault Brigade and Polish 6th Airborne Brigade to conduct a multi-national jump on to a designated drop zone. At the same time, the Europe-based 173rd Airborne Brigade deployed from staging bases in Germany to conduct airborne assaults on to training areas in the north of Poland.

The exercise transitioned to southeast Germany, where the multi-national airborne task force conducted a combat training center field exercise at the Army's Grafenwoehr and Hohenfels Training Areas.

Swift Response is one of a series of near-simultaneous exercises in eastern Europe this summer that demonstrates U.S. and allied capabilities and further supports assurance and deterrence measures in the region. The airborne jumps and seizure of key terrain and bridge-crossings set the stage in Poland for the multi-national land force exercise Anakonda, as well as enabling the passage of the U.S. Army's 2nd Cavalry Regiment as they move through the region toward exercise Saber Strike in the Baltics.

# Act swiftly to file PCS carrier claims

When you move to a new duty station and begin unpacking and discover a box of broken item, what can you do?

Under the contract that the Department of Defense has with the carrier industry, service members can get full replacement value, or FRV, for their damaged goods. Note that FRV does not mean you will receive new goods. The carrier can replace, pay full value or repair the damaged items. However, this is conditioned upon timely reporting of a claim.

The Defense Personal Property System is the DOD's web-based system that allows military members to create shipments, schedule delivery and file claims directly with the Transportation Service Provider, also known as the carrier. The TSP offers Full Replacement Value insurance coverage and is usually liable up to a maximum of \$50,000.

Military members must submit their claims within

a specific time frame in order to receive the desired compensation. Upon discovering damage to an item or that an item is missing, the member must file a "Loss/Damage Report" directly to the carrier (by going to [www.move.mil](http://www.move.mil)) within 75 days from the date of delivery. If the member fails to notify the claims office of their loss in time for the office to dispatch notice to the carrier within 75 days from the date of delivery, the member's settlement is reduced by the amount the Air Force would have collected from the carrier — also known as the "potential carrier recovery."

A member must submit supporting documentation for a claim to the carrier within nine months from the delivery date to receive FRV. Members do not have to get estimates, unless asked. If the claim is not submitted in full within nine months from the date of delivery, the member will only be eligible to receive the depreciated value of the damaged or missing items. If the member

fails to file a claim within two years, the claim will likely be barred by the statute of limitations.

Upon proper submission, the carrier should pay, deny or make an offer within 60 days of receipt of a complete, substantial claim. If a member agrees with the amount offered for an item by the carrier they may accept the amount and sign a release for that item. The carrier will complete payment within 30 days.

Every item on which the member does not agree with the carrier's offer can be transferred to the Air Force Claims Service Center. AFCSC has taken over responsibility for Military Personnel and Civilian Employees' Claims Act claims and related carrier recovery claims. The center retains reviewing authority over the Defense Personal Property System.



# 2015 Annual Drinking Water Quality Report

We're pleased to present to you this year's Annual Drinking Water Quality Report. This report is designed to inform you about the quality water and services we deliver to you every day. Our goal is to provide you with a safe and dependable supply of drinking water, and we want you to understand, and be involved in, the efforts we make to continually improve the water treatment process and protect our water resources.

## Where Does Our Drinking Water Come From?

The sources of drinking water (both tap water and bottled water) include rivers, lakes, streams, ponds, reservoirs, springs, and wells. We purchase treated water from Jacksonville Water Works whose sources are twelve wells that pump from the Quaternary System Aquifer. Jacksonville Water Works also purchases water from Central Arkansas Water, which receives its supply from two surface water sources: Lake Winona and Lake Maumelle. Both lakes can supply Jackson Reservoir, a regulating reservoir located in Little Rock. Water is delivered by pipeline to the Jack H. Wilson and Ozark Point water treatment plants. Both treatment facilities are located in Little Rock.

## How Safe Is The Source Of Our Drinking Water?

The Arkansas Department of Health has completed Source Water Vulnerability Assessments for Jacksonville Water Works and Central Arkansas Water. The assessments summarize the potential for contamination of our sources of drinking water and can be used as a basis for developing source water protection plans. Based on the various criteria of the assessments, our water sources have been determined to have a low to high susceptibility to contamination. You may request summaries of the assessments from our office.

## What Contaminants Can Be In Our Drinking Water?

As water travels over the surface of the land or through the ground, it dissolves naturally occurring minerals and, in some cases, can pick up substances resulting from the presence of animals or from human activity. Contaminants that may be present in source water include: Microbial contaminants such as viruses and bacteria, which may come from sewage treatment plants, septic systems, agricultural livestock operations, and wildlife; Inorganic contaminants such as salts and metals, which can be naturally occurring or result from urban stormwater runoff, industrial or domestic wastewater discharges, oil and gas production, mining, or farming; Pesticides and herbicides which may come from a variety of sources such as agriculture, urban stormwater runoff, and residential uses; Organic chemical contaminants including synthetic and volatile organic chemicals, which are by-products of industrial processes and petroleum production, and can also come from gas stations, urban stormwater runoff, and septic systems; Radioactive contaminants which can be naturally occurring or be the result of oil and gas production and mining activities.

In order to assure tap water is safe to drink, EPA has regulations which limit the amount of certain contaminants in water provided by public water systems. Food and Drug Administration (FDA) regulations establish limits for contaminants in bottled water which must provide the same protection for public health.

## Am I at Risk?

All drinking water, including bottled water, may reasonably be expected to contain at least small amounts

of some contaminants. The presence of contaminants does not necessarily indicate that the water poses a health risk. However, some people may be more vulnerable to contaminants in drinking water than the general population. Immuno-compromised persons such as persons with cancer undergoing chemotherapy, persons who have undergone organ transplants, people with HIV/AIDS or other immune system disorders, some elderly, and infants can be particularly at risk from small amounts of contamination. These people should seek advice about drinking water from their health care providers. More information about contaminants and potential health effects can be obtained by calling the Environmental Protection Agency's Safe Drinking Water Hotline at 1-800-426-4791. In addition, EPA/CDC guidelines on appropriate means to lessen the risk of infection by microbiological contaminants are also available from the Safe Drinking Water Hotline.

## What is Cryptosporidium?

Cryptosporidium is a microbial pathogen found in surface water throughout the U.S. It lives and reproduces only with the host. In the environment, Cryptosporidium exists as a thick walled oocyst, containing four organisms. Monitoring by Central Arkansas Water in 2015 indicated no presence of these organisms in their Lake Maumelle, Lake Winona, or Jackson Reservoir water sources. It is important to know that although filtration removes Cryptosporidium, the most commonly used filtration methods cannot guarantee 100 percent removal. Ingestion of Cryptosporidium may cause cryptosporidiosis, an abdominal infection. Symptoms of infection include nausea, diarrhea, and abdominal cramps. Most healthy individuals can overcome the disease within a few weeks. However, immuno-compromised people are at greater risk of developing life threatening illness. We encourage immuno-compromised individuals to consult their doctor regarding appropriate precautions to take to avoid infection. Cryptosporidium must be ingested to cause disease, and it may be spread through means other than drinking water.

## Lead and Drinking Water

If present, elevated levels of lead can cause serious health problems, especially for pregnant women and young children. Lead in drinking water is primarily from materials and components associated with service lines and home plumbing. We are responsible for providing high quality drinking water, but cannot control the variety of materials used in plumbing components. When your water has been sitting for several hours, you can minimize the potential for lead exposure by flushing your tap for 30 seconds to 2 minutes before using water for drinking or cooking. If you are concerned about lead in your water, you may wish to have your water tested. ## TEST RESULTS

The 19th Medical Group Bioenvironmental Flight, Jacksonville Water Works and Central Arkansas Water routinely monitor for constituents in your drinking water according to Federal and State laws. The test results table shows the results of our monitoring for the period of January 1st to December 31st, 2015. In the table you might find terms and abbreviations you are not familiar with. To help you better understand these terms we've provided the following definitions:

**Action Level** - the concentration of a contaminant which, if exceeded, triggers treatment or other requirements which a water system must follow.

**Maximum Contaminant Level (MCL)** - the highest level of a contaminant that is allowed in drinking water. MCLs are set as close to the MCLGs as feasible using the best available treatment technology.

**Maximum Contaminant Level Goal (MCLG)** - unenforceable public health goal; the level of a contaminant in drinking water below which there is no known or expected risk to health. MCLGs allow for a margin of safety.

**Maximum Residual Disinfectant Level (MRDL)** - the highest

# Forced distribution driving more promotions for top performers

WASHINGTON (AFNS) – Results of the first promotion board using the forced distribution process were released May 25, highlighting a close connection between commander recommendations and those selected for promotion.

“These results are achieving the intended purpose of the new evaluation and promotion systems we previewed to our enlisted force during last year’s roadshows,” said Lt. Gen. Gina Grosso, the deputy chief of staff for manpower, personnel and services. “Performance assessment, along with input from supervisors at all levels, is helping identify and promote our top performers.”

The 5,019 technical sergeants selected for promotion, out of 21,504 eligible, represent an increase in the overall selection rate of 23.3 percent compared to last year’s rate of 22.4 percent. The selection rate to technical sergeant continues to move closer to the historical average of 24.2 percent selection rate following the reduced rates associated with the force management drawdown in 2014.

Promotion recommendations had a significant impact on promotion selection. Ninety percent of Airmen who received a “promote now” and 75 percent of the Airmen who received a “must promote” were promoted to master sergeant.

Additionally, and as intended, more than 2,000 Airmen receiving a “promote” recommendation were also selected for promotion -- nearly 41 percent of the 5,019 selected for promotion.

“We built the system to ensure Airmen who received the



highest promotion recommendations from their commanders would have a significant advantage, while also ensuring Airmen who received a promote recommendation would remain competitive,” said Chief Master Sgt. of the Air Force James A. Cody. “These results show us we’re moving in the right direction, and should help alleviate concerns Airmen may have had about not being promotable without one of the top recommendations.”

Earlier this year, the Air Force conducted and released the results of the senior master sergeant and chief master sergeant promotion boards, which were the first to use restricted stratification. Restricted stratification limited the number of stratifications senior raters could give to their master sergeant and senior master sergeant

promotion eligible populations to the top 10 and 20 percent, respectively.

In March, 1,467 Airmen were selected for promotion to senior master sergeant at a 12.3 percent selection rate – a significant increase from last year’s rate of 8.75 percent. About 57 percent of those with a stratification were selected, while 5 percent of those without one were selected. Overall, 32 percent of all selects, about 470, did not receive a stratification.

In November, 525 Airmen were selected for promotion to chief master sergeant at a 20.8 percent overall selection rate – also an increase from last year’s rate of 18.9 percent. About 54 percent of those with a stratification were selected, while about 7 percent of those without one were selected. Overall, 23 percent of all selects, about 120, did not receive a stratification.

“The results clearly highlight the positive effects forced distribution and restricted stratification have on our enlisted evaluation and promotion systems,” Cody said. “Job performance remains the most important factor when considering Airmen for promotion, and our top performers now have the advantage toward promotion they deserve.”



“The uncertainty of the future environment, coupled with constrained resources, demands that we take actions now to ensure enterprise-wide success in the future,” Everhart said.


One recent development made toward championing Rapid Global Mobility is AMC’s first Mobility Guardian exercise.


