## Base Entry Requirements:

### Personnel:

- Dept. of Defense Identification
- DoD Dependent Identification
- Valid Drivers License, Registration, and Insurance
- ALL guests MUST always have a valid visitor's pass on their person.
- Contact 19 Security Forces Squadron Pass & Registration with questions: 987-4805, Bldg 1508

### Guests:

- To sign-on guests not affiliated with the DoD (i.e. civilian friends/family) you must take them to the Visitor's Control Center at Vandenberg Gate. To obtain a pass guests will need:
  - A valid, government issued ID, i.e. driver's license.
  - Sponsors of guests who are not U.S. citizens, or do not possess valid INS documents, i.e. a Resident Alien Card, must coordinate their visit, no less than 5 business days in advance. Contact Pass & Registration: 987-4805.
  - The Visitor's Center can issue a Visitor's pass for up to 7 days.
  - Sponsors of guests who require a pass longer than 7 days must coordinate with 19 SFS Pass & Registration: 987-4805.

### Vehicles:

- Valid driver's license
- Authorized Identification (*see personnel*)
- Valid vehicle registration (Hard copy)
- Valid vehicle proof of insurance (*e-copy OK*)

## Driving:

- MUST use hands free devices while driving on the installation. Texting/talking & driving not allowed.
- Radio Detection & Ranging (RADAR) detectors and DASH CAMS will not be used or visible on the installation.

## After Hours Passes:

- Sponsors/visitors should park in the Visitor Center parking lot and contact the Security Forces member on duty to request a visitor pass.
- Security of the installation is the Security Forces members main priority. Be patient! The members at the gate will complete your visitors pass when they are available to do so.
- If there is a problem getting a pass for whatever reason, you may request to speak to the on-duty Flight Chief. Do not be verbally combative with the Sentry for following rules set in place.

## Motorcycles, Motor Scooters and Mopeds:

### Personal Protection Equipment:

- A helmet, certified to meet current Federal Motor Vehicle Safety Standard No. 218 (DOT) or Snell Standard M2005 shall be worn and properly fastened under the chin.
- Shatter resistant eye protection (glasses, face shield)
- Long sleeve shirt or jacket
- Long trousers
- Full-fingered gloves
- Over the ankle footwear, i.e. boots.

## Little Rock AFB Curfew:

10 p.m. to 5 a.m. Mon–Thu, Midnight to 5 a.m. Fri, Sat & on nights prior to a holiday, 11 p.m. to 5 a.m. on Sundays. Juveniles returning from school/church event, including employment, may be granted a 1-hour curfew extension at the end of event or work. Juveniles must have a signed letter from a parent, employer, or activity director. Letters must include base address, phone number, and normal hours of employment/activity. Travel is only allowed from the gate directly to the residence. Juveniles found north of Arnold Dr. or outside normal housing channels during curfew hours will be considered in violating curfew.

## Interacting with Security Forces:

- Security Forces actively patrol in a law enforcement and security capacity. Their primary duty is the protection of assets and personnel on the installation. This includes verifying credentials at the installation gates, creating visitor passes, monitoring speed utilizing Light Detection & Ranging (LIDAR), and Installation Entry/Exit Vehicle Checks.
- Security Forces enjoys a robust partnership with local authorities. Any instance of emergency, Security Forces patrols will respond. In the event a civilian is determined to be a suspect or a person of interest, civilian authorities will also respond.
- If Security Forces members make contact with you, please be respectful, remain calm, and provide clear/concise answers to any questions. They will announce themselves and notify you why they are interacting with you. Be compliant and listen to their instructions so they can resolve the situation in a timely manner.

## Traffic Stops:

- Activate your turn signal and pull your vehicle to a safe location on the side of the road or in a parking lot as soon as it is safe to do so.
- DO NOT get out of your vehicle unless instructed to do so.
- Turn off the engine and any audio devices.
- Stay in your vehicle unless directed otherwise by the Security Forces member.
- Turn on your interior lights at night to assist with visibility. Security Forces may use a spotlight for additional visibility.
- **ALWAYS** Keep your hands visible at all times. Do not reach for anything until told to do so.
- Follow instructions throughout the traffic stop.
- You will be afforded the opportunity to rebut the citation at Bldg. 481 Reports & Analysis. The Security Forces member issuing the citation will explain the rebuttal process at the conclusion of the traffic stop.
- Displaying an attitude will only make the situation more difficult for both parties and a traffic stop is not the time to be verbally combative.

## Installation Entry/Exit Vehicle Checks (IEVC):

- IEVCs will be conducted at the time and location set by the 19 Mission Support Group Commander. It is not the Security Forces members decision to select you for an IEVC. It is strictly based on a randomization set forth by the 19 MSG/CC.
- IEVCs are an inspection looking for government property, contraband, and/or classified material.
- Security Forces member will contact the driver and ask if they agree to the inspection. Driver will be asked to open all compartments (interior and exterior).
- Refusals may result in loss of base driving privileges or debarment from the installation.
- **MILITARY** members who refuse will be apprehended for violation of Article 92 (UCMJ).
- **CIVILIANS** entering who refuse will be denied entry to the installation.
- **CIVILIANS** exiting the installation may be barred from base.

## Gate Closures:

- Gate closures will be initiated during certain incidents affecting the base.
- DO NOT call the Law Enforcement Desk asking why the gate is closed. It will be opened when the situation is resolved.
- DO NOT conduct a U-turn OR attempt to go out through another gate as they will all be closed, and U-turns are illegal throughout the base.
- When entering the installation, listen to the Security Forces members instructions as they will constantly leave a vehicle in the inbound lane of traffic as a blocking force.

## Crime Prevention:

- **ALWAYS** lock your house and cars.
- Monitor your children and **ALWAYS** keep accountability of their whereabouts.
- REMEMBER: LRAFB is a **No-Drone Zone!** No drones are allowed to operate on LRAFB.
- Report all suspicious activity to SF Law Enforcement desk. Security Forces must see traffic violations in person. We want to hear from you!

## Report Requests:

- If you wish to report a vehicle accident it must be reported to the Law Enforcement Desk within 3 days.
- If you would like to request a police report you must go to Bldg. 481/Reports & Analysis. The Law Enforcement Desk does not have access to these reports.

## Weapons:

### Prohibited Items:

- Switchblade or any knife that folds, closes, or retracts into the handle or sheath and opens automatically by pressure applied to a button or other device located on the handle opens or releases a blade from the handle or sheath by force of gravity or centrifugal force
- Knives with blades longer than 3 1/2 inches
- Brass, metal or other type knuckles
- Explosives (fireworks, pyro, hand grenades)
- Pepper spray/tear gas (150cc)
- Throwing stars, Butterfly knives, blackjacks, swords, nunchucks

### Firearms/Weapons on Base:

- Concealed carry is **NOT AUTHORIZED** on base.
- Firearms being transported from base housing off base and vice versa must be locked in a box, separated from the ammunition, AND outside of arms reach of the operator.

### Storing Weapons:

- Base Housing/Fam Camp: Weapons are required to be registered within 14 days.
- Dorms/Temp Lodging: Weapons must be stored elsewhere (SF Armory, off-base, Jacksonville Police Department Courtesy Storage).

**Security Forces DOES NOT handle vehicle/housing lockouts (EXCEPT for emergencies), dead batteries, courtesy rides, or lost/stray animals unless hostile.**
