## Goals

Empower residents to voice concerns stemming in open conversations for all stakeholders to enhance programs, processes, and procedures resulting in a safe and healthy housing environment.

Networking between residents.

Opportunity for the Privatized Housing Resident Advocate to aggressively report issues through proper chains of command for action.

## Reporting Requirements

The Privatized Housing Resident Advocate, Military Housing Office and Project Owners hold follow-on meetings to discuss and resolve issues which are addressed during the Resident Council meetings.

All issues discussed at the Resident Council will be presented at the quarterly Installation Management Review Committee for information purposes and/or follow-on actions for unresolved issues.
