

# Eligibility Guide

**Instructions:** This table is a quick reference guide to assist with finding the appropriate service provider given the Airman/Guardian's DAF affiliation. To use the table, first identify the DAF affiliation on the left, then check for any corresponding "◆" in the row to identify the available service provider(s) listed in the columns at the top. An "◆" in a corresponding column/row indicates the member is eligible to receive support from the service provider. There may be more than one service provider option per affiliation. Work with the Airman/Guardian to identify service provider preference.

Note: Allied Forces refers to service members and individuals from other countries who are stationed at a U.S. military installation. They are eligible for full benefits if they are registered in DEERS. They will either have a DoD ID Card, an Allied Forces Card, or an official letter stating they are eligible for all the benefits due a member of the U.S. military. If they are not registered in DEERS and/or do not have a card or letter, they are still eligible for limited benefits.
