Courts-Martial

Article 15 Actions (Non-Judicial Punishment)

An Airman First Class received a reduction to Airman Basic, suspended forfeitures of \$840.00 for 2 months and a reprimand for drunk driving, child endangerment, and resisting apprehension, violations of Article 113, Article 119, and Article 87 of the UCMJ.

An Airman First Class received forfeitures of \$1,021.00 pay and a reprimand for failing to obey a lawful order by wrongfully possessing alcoholic beverages in the dorm while under the legal drinking age of twenty-one, a violation of Article 92 of the UCMJ.

An Airman First Class received a reduction to Airman and a reprimand for wrongful use of marijuana, a violation of Article 112a of the UCMJ.

An Airman First Class received restriction to base for 14 days and a reprimand for failing to obey a lawful order by wrongfully possessing alcoholic beverages in the dorm, a violation of Article 92 of the UCMJ.

An Airman First Class received a reduction to Airman and a reprimand for false official statement, a violation of Article 107 of the UCMJ.

An Airman First Class received a suspended reduction to Airman, 10 days extra duty, and a reprimand for disrespect towards a noncommissioned officer and false official statement, violations of Article 91 and 107 of the UCMJ.

An Airman First Class received a suspended reduction to Airman and a reprimand for failing to obey a lawful order by wrongfully possessing alcoholic beverages while under the legal drinking age of twenty-one, a violation of Article 92 of the UCMJ.

A Senior Airman received a reduction to Airman First Class and a reprimand for wrongful use of marijuana, a violation of Article 112a of the UCMJ.

Involuntary Discharges

Three Airmen First Class and one Airman were discharged with an Under Honorable Conditions (General) service characterization for minor disciplinary infractions.

One Senior Airman, two Airmen First Class, and one Airman were discharged with an Under Honorable Conditions (General) service characterization for drug abuse.
