Courts-Martial

An Airman First Class was found guilty of wrongfully importing a controlled substance into the United States on divers occasions and for wrongfully possessing a controlled substance on divers occasions in violation of Article 134, UCMJ. The member was sentenced to a reduction to E-1, 10 days of confinement, and 15 days restriction to Little Rock Air Force Base.

Article 15 Actions (Non-Judicial Punishment)

An Airman First Class received a reduction to Airman, five days extra duty and a reprimand for failing to obey a lawful order by wrongfully traveling outside the state of Arkansas, in violation of Article 92, UCMJ.

A Staff Sergeant received a suspended reduction to Senior Airman and a reprimand for failing to abide by a restriction of movement order in violation of Article 92, UCMJ.

A Staff Sergeant received a reduction to the grade of Senior Airman, seven days extra duty, and a reprimand for failing to maintain social distancing requirements in violation of Article 92, UCMJ.

A Senior Airman received a reduction to Airman First Class, five days extra duty, suspended forfeiture of \$1,151.00 pay per month for two months, and a reprimand for failing to obey a lawful order by wrongfully traveling outside the state of Arkansas in violation of Article 92, UCMJ, and for making a false official statement in violation of Article 107, UCMJ.

An Airman First Class received a reduction to Airman, suspended forfeiture of \$250.00 pay per month for two months, 30 days restriction to base, and a reprimand for failure to go to their place of duty in violation of Article 86, UCMJ.

A Senior Airman received a reduction to Airman First Class, suspended forfeiture of \$1,151.00 pay per month for two months, and a reprimand for failure to refrain from using a meal card to obtain subsistence while receiving full Basic Allowance for Subsistence in violation of Article 92, UCMJ.

A Master Sergeant received a reduction to Technical Sergeant, thirty days extra duty with twenty-three extra duty days suspended, forfeiture of \$2,086.00 pay per month for two months, and a reprimand for being drunk on duty in violation of Article 112, UCMJ, damaging nongovernment property with a value under \$500.00 in violation of Article 109, UCMJ, and unlawfully entering a structure in violation of Article 129, UCMJ.

An Airman First Class received a reduction to Airman, forty-five days extra duty, suspended forfeiture of \$971.00 pay per month for two months, and a reprimand for animal neglect in violation of Article 134, UCMJ.

An Airman First Class received fifteen days restriction to base and a reprimand for consuming alcohol while under the legal drinking age of 21 in violation of Article 92, UCMJ.

A Staff Sergeant received a reduction to Senior Airman, forty-five days extra duty, suspended forfeiture of \$1,373.00 pay per month for two months, and a reprimand for failing to obey a nocontact order and failing to refrain from driving a vehicle onto base with a person concealed in the trunk of the vehicle in violation of Article 92, UCMJ.

A Senior Airman received a reduction to Airman First Class, fourteen days extra duty, and a reprimand for failing to maintain social distancing requirements in violation of Article 92, UCMJ.
