Article 15 Actions (Non-Judicial Punishment)

A Staff Sergeant assigned to the 314th Maintenance Group received a suspended reduction to Senior Airman for violation of Article 87 – Missing movement.

A Staff Sergeant assigned to the 19th Security Forces Squadron received a reprimand for violation of Article 92 – Dereliction of duty (did not conduct proper check prior to issuing pass).

A Staff Sergeant assigned to the 19th Civil Engineer Squadron received a reduction to Senior Airman suspended for violation of Article 121 – Wrongful appropriation.

An Airman First Class assigned to the 19th Security Forces Squadron received a reduction to Airman suspended and 15 days extra duty for violation of Article 92 – Dereliction of duty (did not verify an individual's valid identification credentials).

An Airman First Class assigned to the 714th Training Squadron received a reduction to Airman, and 14 days restriction to base for violation of Article 92 – Failure to obey a lawful order (bringing alcohol into the dorms).

An Airman First Class assigned to the 714th Training Squadron received a suspended reduction to Airman, forfeiture of \$150 pay, and 10 days restriction to base for violation of Article 92 – Dereliction of duty (underage drinking).

An Airman First Class assigned to the 19th Logistics Readiness Squadron received a suspended reduction to Airman and forfeiture of \$918 pay for violation of Article 92 – Dereliction of duty (underage drinking).

An Airman First Class assigned to the 19th Logistics Readiness Squadron received a suspended reduction to Airman and forfeiture of \$918 pay for violation of Article 92 – Dereliction of duty (underage drinking).

An Airman First Class assigned to the 19th Logistics Readiness Squadron received a suspended reduction to Airman, forfeiture of \$918 a month for two months, and 30 days restriction to base for violation of Article 92 – Dereliction of duty (providing alcohol to individuals under the legal drinking age).

An Airman Basic assigned to the 19th Civil Engineer Squadron received a forfeiture of \$818 a month for 2 months and 60 days restriction to base for violation of Article 112a – Wrongful use of Marijuana.

Involuntary Discharges

An Airman was discharged with an Honorable service characterization for failure to meet minimum fitness standards.

An Airman First Class was discharged with an Honorable service characterization for failure to progress in military training.

An Airman was discharged with an Honorable service characterizations for conditions that interfere with military service.

An Airman Basic was discharged with a General service characterization for sexual assault.

An Airman and an Airman Basic were discharged with a General service characterization for drug abuse.

An Airman First Class was discharged with an Under Other Than Honorable Conditions service characterization for discharge in lieu of court-martial.
